RULES & REGULATIONS FOR EXHIBITOR

- 1. Exhibitors and Registrants (hereinafter also referred to as Applicants) shall be bound by the conditions rules and regulations set forth in this agreement and any changes must be made in writing and signed by an authorized official of Agra Footwear Manufacturers & Exporters Chamber (hereinafter referred to as AFMEC) who shall have full power to interpret and to make or amend these rules provided that such amendments and additions do not operate to diminish the rights reserved for the Exhibitor/Registrant under this contract/application and shall not operate to increase liabilities of its Sponsors, Agents, or Employees.
- 2. No Exhibitor shall be permitted to exhibit unless he has paid prior to the Exhibition all of the fees agreed.
- 3. Exhibitors are expected to comply with the building regulations and all Government rules regulations.
- 4. Rights of an Exhibitor shall not be assignable to any other firm or person and Exhibitor may not assign his space or sublet the whole or any part of the space contracted for.
- 5. Exhibit shall not obstruct the view of adjoining exhibit nor be operated in any manner objectionable to other exhibitors. All lighting within the exhibit must be arranged and operated so as not to be distracting to adjacent exhibits. Phonograph radios or other sound devices operated in a manner objectionable to the Organizers shall be prohibited.
- 6. Exhibitor shall not permit raffles/donations or other promotional measures that requires members or guests to be present at a specified location and time. All unusual promotional plans must be approved by the Organizers.
- 7. Attendance hours shall be controlled solely by the Organizers which will specify hours etc. and admission shall be by ticket or badge, and identification badges shall not be transferable.
- 8. No Exhibitor will be allowed to remove his exhibit from the Exposition Floor prior to the official termination of the Exhibition, and the Exhibitor shall have an $authorized \ representative \ present \ at \ the \ Exhibition \ throughout \ the \ exhibition \ period \ and \ during \ the \ installation \ ad \ dismantling \ of \ his \ exhibit.$
- 9. The Organizers, AFMEC Sponsors, its Employees or Agents are not responsible for any loss, theft or damage by fire or injury of any nature to any person or article. Reputable watchmen will be on duty day and night, but the Organizers, while taking precautions against loss, will not guarantee against it and it is hereby $expressly\, released\, from\, and\, liabilities\, for\, injury\, or\, damage\, there\, from.$
- 10. The Publisher of the Catalogue, AFMEC the Organizers, Sponsors, its Agents or Employees will not be responsible for any errors or omissions on copy prepared and submitted by the Advertisers or Exhibitors.
- 11. The execution of the Application and its receipt by AFMEC is deemed conclusive evidence of the Applicants agreement to pay the full fees due from the moment. The Application is non-cancelable by the Applicant further acknowledge that, having incurred expenses as a result of the contract/application is not required to refund any of the fees agreed to.
- 12. The Organizers, AFMEC Sponsors, its Agents or Employees shall not be liable for loss, damage or delay resulting from acts of war, civil commotion, strike or lockouts intervention or regulation, military activity or any other circumstances which shall make it impossible or inadvisable for the Organizers to hold the Exhibition/Conference at the time and place provided, and the Exhibit Committee reserves the right to reschedule the Exhibition at a later date and/or at an alternate site. Furthermore, AFMEC will not be responsible and will be held harmless should any conflict or misinterpretations arise with the host country, its sponsors, agents or other bodies regarding any and all aspects of the Exhibition, which may effect the Exhibitors. The said Exhibitor acknowledges that AFMEC has sustained damages and losses as result of the foregoing, as well, and shall and does hereby waive all claims for damages or compensation. The sums paid to $AFMEC \, as \, fees \, or \, otherwise \, in \, connection \, with \, the \, Exhibition \, shall \, remain \, the \, property \, of \, AFMEC.$
- 13. The Organizers are not responsible to assist the Exhibitor in obtaining passport and visa, for entrance into the country where the exposition is to be held. The fact that the Exhibitor is unsuccessful in obtaining the documents from the necessary government authorities will not constitute a basis for cancellation of this contract/application and it is clearly understood that no refunds whatsoever will be made. The Exhibitor however, may substitute another party or company who meets the entry and government formalities be held. Such substitution shall be the sole responsibility of the contracting Exhibitor.
- 14. The Organizers, AFMEC Sponsors, its Agents or Employees are not responsible for any loss, damage or delay incurred in freight shipments (transport, handling, and clearing) into and out of the country in which the Exposition is held. Exhibitors are urged to adequately insure all shipments.
- 15. AFMEC is not responsible for any commercial transactions. This agreement shall be governed and construed according to the Indian Law. Any dispute between the parties under this agreement hereby, will be settled in the jurisdiction of Agra Court.
